

GREENHOUSE PESTICIDES AND RESTRICTED ENTRY INTERVAL

In compliance with the Federal Worker Protection Standard all pesticide labels will soon display a Restricted Entry Interval (REI). The REI limits entry to the treated area for a stated number of hours after the pesticide application. During the REI only workers and handlers with proper protective clothing and special training are allowed to enter the treated area. Compliance with label-stated REI's begins April 15, 1994. However, pesticides that are on-hand without the REI and WPS working on the label may be used up in the proper manner according to the label on the container.

The following is a list of commonly used greenhouse pesticides and their anticipated REI's.

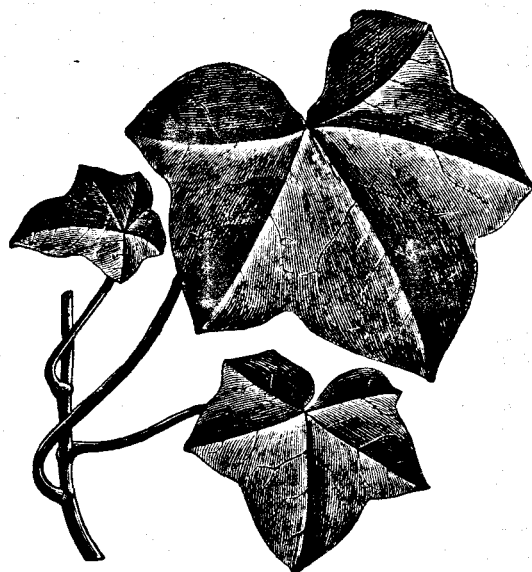
